Full Membership	Membership is entitled to all privileges for the member and dependent family. (Dependent family includes any member claimed by the member as a dependent income tax exemption.) This consists of all clubhouse, social, golf, and swimming privileges.
Non-Resident/Out of State	Non-resident —Privileges same as Full Membership. Restricted to persons living 40 miles or more from the club.
Retired Membership	Retired Club Member —Restricted to members 65 and older and retired. Privileges same as Full Membership.
Golf Membership	Golf Membership —Provides privileges of the golf course and clubhouse for golf associated activities only.
Social	Social - Provides privileges of the club house and surrounding areas for social events held by the club.
Weekday Membership	Weekday Only - Provides membership privileges for the golf course Monday thru Friday. Member may still play in tournaments on weekends.
